Cailee reported that Olcese had \$1,028,582.61 starting funds in 2024. For the period April-June, Olcese had expenses of (\$179,688.53) and total revenue of \$215,977.00 which came from the hydro and water tolls from the golf course, leaving a balance as of June 30, 2024 in the amount of \$1,011,063.13. The total deferred Hydro Royalty/Interest due is \$10,027,528.80. It was moved by Director Bob Teagarden, seconded by Director Siemens, and unanimously carried, that the Treasurer's Report be approved.
